*** Added reward from Uncle Sam.** A portion of long-term care premiums may be deducted on federal income tax returns. Tax deductions or credits are also available in many states. "It's like a gift, a nice incentive, and it keeps recurring," says Westrup. "You can set yourself up for 2016 and every year after."

"Long-term care insurance is truly a gift that keeps on giving," says Westrup. "You'll have less to worry about this holiday season, and every holiday season from here on. You can relax and enjoy the festivities and one another."
